4           Q     IS THE BEDROOM CHANGED, ITSELF?

5           A     THE BEDROOM CHANGED, ITSELF?

6           Q     YOU SAID THE BED WAS MOVED. HAD THE BEDROOM,  
7 ITSELF, CHANGED?

8           A     THE BED HAS BEEN CHANGED FACING EAST AND WEST,  
9 TO NORTH AND SOUTH NOW.

10          Q     HAS THERE BEEN ANY OTHER CHANGES IN THAT ROOM?

11          A     YEAH. ALL THE FURNITURE HAS BEEN CHANGED, MOST  
12 OF IT.

13          Q     HAVE THE WALLS OR THE STRUCTURE OF THE BEDROOM  
14 CHANGED?

15          A     NO.

16                   MR. EIDE: THANK YOU. NO FURTHER QUESTIONS OF  
17 THIS WITNESS.

18                   THE COURT: REDIRECT?

19                   MR. BENDER: YES, SIR.

20                                   REDIRECT EXAMINATION

21 BY MR. BENDER:

22           Q     MR. STOCKWELL, IN REGARDS TO THE QUESTIONS THAT  
23 MR. EIDE HAS ASKED YOU ON CROSS-EXAMINATION, REGARDING  
24 WHETHER OR NOT YOU WERE AWARE THAT YOUR WIFE HAD FOR A  
25 SHORT TIME LEFT YOUR BEDROOM.

1           YOU STATED THAT SHE TOOK ANGELA TO GET SOME  
2 CHILDREN'S ASPIRIN. HOW DID YOU FIND OUT THAT INFORMATION?

3           A     SHE TOLD ME. 

4           Q     SO AT THE TIME WHEN YOU WOKE UP AND THEY CAME IN  
5 THE ROOM, DID YOU THINK THAT ANYTHING UNUSUAL HAD HAPPENED,  
6 OR ANYTHING, TO WARRANT YOUR SUSPICION OR CONCERN AT THAT  
7 POINT IN TIME?

8           A     YES. WE WERE SURPRISED BECAUSE THEY ALMOST NEVER  
9 WAKE UP DURING THE NIGHT, ESPECIALLY THAT TIME OF NIGHT.

10          Q     OTHER THAN THAT, WERE YOU CONCERNED ABOUT ANYTHING  
11 ELSE?

12          A     I WAS PUZZLED BUT NOT REAL CONCERNED. BECAUSE  
13 IT APPEARED TO ME THAT THE REASON WAS THE LEG CRAMP.

14          Q     AND THEN DID YOU GO BACK TO BED AFTER THAT EPISODE?

15          A     YEAH. I WAS UNDISTURBED, AND I WENT ON BACK TO  
16 SLEEP FAIRLY SHORTLY.

17          Q     SO THE STATEMENT THAT YOU GAVE AT YOUR DEPOSITION,  
18 AS OPPOSED TO TODAY, IS MERELY ONE THAT YOU HAVE CORRECTED  
19 AND WERE NOT REALLY SURE OF EXACTLY WHAT HAPPENED?

20          A     THAT'S RIGHT. 

21          Q     SO YOUR TESTIMONY TODAY IS MORE ACCURATE THEN AT  
22 THE TIME OF THE DEPOSITION, AFTER HAVING TIME TO REFLECT  
23 AND TALK?

24          A     YES.
