24 Q YOU NEVER TOLD HER ABOUT THE EXTRA SET OF KEYS

1 A NO. I DON'T LET HER DRIVE.

2 Q I'M SORRY?

3 A I DON'T LET HER DRIVE MY TRUCK.

4 Q MY QUESTION IS: YOU DIDN'T TELL HER?

5 A NO, I DIDN'T.

6 Q NOW, WHEN SCOTT CALLED YOU ABOUT TEN O'CLOCK,

7 YOU SAID --

8 A IT WAS ABOUT 9:30.

9 Q -- TO COME AND PICK HIM UP AT HIS GRANDMOTHER'S
10 TRAILER PARK, YOU WENT AND PICKED HIM UP.

11 DID YOU STOP ANYWHERE BEFORE YOU MADE IT BACK

3 YOU ALL HAVE DINNER WHEN YOU GOT BACK?

4 A I REALLY CAN'T REMEMBER.

5 Q WELL, DID YOU SEE ANYONE EAT?

6 A NO, NOT THAT I CAN REMEMBER.

7 Q YOU DON'T RECALL EATING HAMBURGERS OR A POT
8 ROAST?

9 A NO.

10 Q DID YOU WATCH ANY VIDEO TAPES?

11 A I WATCHED HALF OF A SHOW, WHICH WAS ON TV, AND
12 THEY WENT OUT AND RENTED SOME.

13 Q WHO WENT OUT AND RENTED SOME VIDEOS?

14 A MICHAEL HYLAND AND MY BROTHER.

15 Q DID YOU SEE MICHAEL HYLAND COME BACK WITH ANY
16 BEERS?

17 A I'M NOT REALLY SURE. I WAS IN BED.

18 Q HOW DO YOU KNOW HE CAME BACK WITH VIDEOS?

19 A BECAUSE THEY WERE WATCHING VIDEOS ALL NIGHT.

20 Q YOU WENT TO BED BEFORE THEY GOT BACK?
